Terms and Conditions**

PLEASE NOTE THAT SEFAPANE LODGE AND SAFARIS RESERVES THE RIGHT TO RESTRUCTURE SAFARI PROGRAMMES IN ACCORDANCE WITH SPACE AVAILABILITY. ALL ACTIVITIES WILL BE ACCOMMODATED.

TERMS AND CONDITIONS

These Terms are applicable to all Contracts of any kind made by Sefapane Lodge and Safari's and its clients ("the Clients") and apply to all reservations, bookings and agreements for accommodation, dining, function room hire and use of all facilities at Sefapane Lodge and Safaris.

Clients are invited to read these provisions and note their responsibilities, arrangements for payments, cancellation terms and limitations on the liability of Sefapane Lodge and Safari's. The Contract is conditional on the payment of the Deposit.

TERMS OF SUPPLY

1. PROVISIONAL RESERVATION AND CONFIRMATION OF RESERVATIONS

1.1 If Sefapane Lodge and Safari's confirms the reservation this Contract is conditional on the Client supplying credit card details and the authority for charges to be deducted (including cancellation charges) on the payment terms outlined in the Schedule.

1.2 If credit card details and payment authority is not given to Sefapane Lodge and Safari's by the Client then subject to any outstanding obligation due to Sefapane Lodge and Safari's from the Client the Contract will cease to be of effect. The Services that are the subject of the provisional reservation will be released and be resold without any further notification to the Client.

2. SUPPLY OF THE SERVICES

2.1 Sefapane Lodge and Safari's shall provide the Services to the Client subject to the Contract.

2.2 The Client shall at its own expense supply Sefapane Lodge and Safari's with all necessary data or other information relating to the Services within sufficient time to enable Sefapane Lodge and Safari's to provide the Services in accordance with the Contract. The Client shall ensure the accuracy of all such information. Specific information requirements are contained in the Schedule. Sefapane Lodge and Safari's may at any time without notifying the Client make any changes to the Services which are necessary to comply with any applicable safety or other statutory requirements, or which do not materially affect the nature or quality of the Services.

3. CHARGES

3.1 The charges payable by the Client shall be detailed in writing by Sefapane Lodge and Safari's. If no charges are specified or additional and varied Services are provided to the Client, the Client shall pay the Standard Charges at the prevailing rate on the day the Services are provided and any additional sums which are agreed between Sefapane Lodge and Safari's and the Client for the provision of the Services .

3.2 Sefapane Lodge and Safari's may vary the Standard Charges from time to time.

3.3 All charges quoted to the Client for the provision of the Services are inclusive of any Value Added Tax at the applicable rate at the tax point unless otherwise stated.

4. DEPOSIT PAYMENTS

4.1 Deposits are non refundable.

5. PAYMENT

5.1 The payments to Sefapane Lodge and Safari's to be made by the Client (including Deposits) are to be made on the date(s) and in the amounts to be calculated as specified in the contract.

5.2 If any services under the contract are varied prior to arrival then the payment made will reflect the latest details contained in the written details of Sefapane Lodge and Safari's.

5.3 Any additional charges due to Sefapane Lodge and Safari's from the Client for the Services shall be paid by the Client on presentation of an invoice.

5.4 Advance to Sefapane Lodge and Safari's Rate: For room reservations made using the advance purchase rate full payment will be taken at the time of booking. This payment is not refundable in the event of any amendment or cancellation.

6. CANCELLATION CHARGES ("NO SHOWS")

6.1 The Client agrees to pay charges to Sefapane Lodge and Safari's in the event of cancellation of the Services or if the Client and/or their guests fail to take up the Services at the time and on the day specified in the Contract.

6.2 Sefapane Lodge and Safari's will provide a cancellation number to a Client in the event of the Client making a cancellation and that number must be used in any future dealings with the Lodge.

7. VARIATION IN SERVICES REQUIRED

7.1 Any variation of numbers, accommodation and food and beverage requirements specified for the Services or other changes or additions must be agreed by the Client and Sefapane Lodge and Safari's in writing.

8. LIABILITY OF SEFAPANE LODGE AND SAFARI'S

8.1 When Sefapane Lodge and Safari's supplies the Services which include any services supplied by a third party, Sefapane Lodge and Safari's does not give any warranty, guarantee or other term as to their quality, fitness for purpose or otherwise, but shall, where possible, assign to the Client the benefit of any warranty, guarantee or indemnity given by the person supplying the services to Sefapane.

8.2 Sefapane Lodge and Safari's shall have no liability to the Client for any loss, damage, costs, expenses or other claims for compensation arising from any instructions supplied by the Client which are incomplete, incorrect, inaccurate, illegible, out of sequence or in the wrong form, or arising from their late arrival or non-arrival, or any other fault of the Client.

8.3 Except in respect of death or personal injury caused by Sefapane Lodge's negligence, or as expressly provided in these Terms, Sefapane Lodge and Safari's shall not be liable to the Client by reason of any representation (unless fraudulent), or any implied warranty, condition or other term, or any duty at common law, or under the express terms of the Contract, for any loss of profit or any indirect, special or consequential loss, damage, costs, expenses or other claims (whether caused by the negligence of the Lodge, its servants or agents or otherwise) which arise out of or in connection with the provision of the Services (including any delay in providing or failure to provide the Services) or their use by the Client, and the entire liability of Sefapane Lodge and Safari's under on in connection with the Contract shall not exceed the amount of the Lodges charges for the provision of the Services, except as expressly provided in these Terms.

9. TERMINATION

Sefapane Lodge and Safari's may (without limiting any other remedy) at any time terminate the Contract by giving written notice to the Client if the Client commits any breach of these Terms, or if the Client goes into liquidation, becomes bankrupt, makes a voluntary arrangement with its creditors or has a receiver or administrator appointed.

10. CLIENT RESPONSIBILITIES

10.1 Dress code: Guests are required to comply with the dress code of Sefapane Lodge and Safari's in the Bar, Gardens and Restaurant. The Client must ensure that any guests of the Client are aware of this requirement.

10.2 Arrival and departure times for accommodation at Sefapane Lodge and Safari's are 2:00 p.m. and 10:00 a.m. respectively. The access and vacate times for all other Services will be as specified in the Programme Sheet and must be strictly adhered to by the Client on all occasions.

10.3 The Client is responsible for the behaviour of his, her or its guests at Sefapane Lodge and Safari's and in particular for the orderly conduct of guests attending any function or staying in Sefapane Lodge and Safari's or otherwise making use of the Services. The Client must ensure that no noise or nuisance is caused either for Sefapane Lodge and Safari's or its other Guests and Clients. The Client must comply with any reasonable request of Sefapane Lodge and Safari's and with any policies of Sefapane Lodge and Safari's as may apply to the Services from time to time.

10.4 Should a resident of the hotel wish for any item to be received or held by Sefapane Lodge and Safari's prior to arrival or following departure, advance notice will be required. The Lodge retains the right to deny receipt of such items. Any costs incurred for return will be borne by the sender. All items are left at the owners risk and may be subject to search. Please note that should an item be locked or sealed, it is the responsibility of the owner of the item to facilitate access. Sefapane Lodge and Safari's is not liable for any flood, fire or damage to the items.

10.5 Smoking in all public areas of the hotel: Sefapane Lodge and Safari's Restaurant, The Tusk Bar is prohibited. Residents of the hotel are able to smoke in a designated smoking bedroom or suite

11. GENERAL

The Contract constitutes the entire agreement between the parties, supersedes any previous agreement or understanding and may not be varied except in writing between the parties. All other terms, express or implied by statute or otherwise, are excluded to the fullest extent permitted by law.

No failure or delay by either party in exercising any of its rights under the Contract shall be deemed to be a waiver of that right, and no waiver by either party of any breach of the Contract by the other shall be considered as a waiver of any subsequent breach of the same or any other provision.

SCHEDULE OF DEPOSITS AND PAYMENTS AND CANCELLATION TERMS

For dining or meeting events as specified in the Contract, final numbers must be received by the contact of Sefapane Lodge and Safari's no less than 48 hours prior to the Reservation Date. Should the number of guests reduce by more than 10% of the total in the Contract, cancellation charges as set out in the Contract will apply and must be paid by the Client based on the total numbers cancelled.

*Where Account Facilities have been confirmed no Deposit is required but the Account is payable in full on receipt of invoice.

**All cancellation charges are subject to possible full reimbursement if accommodation is re-let and payment has been in accordance with Contract.
